ORDER

Heard the counsel for the petitioner. Perused records.

- 2. I am satisfied that the petitioner has made out a prima facie case against the respondents. The object of granting injunction would be defeated by delay, if notice is issued before granting injunction. Hence, the respondents / defendants are restrained by an ad interim order of injunction from infringing the registered trademark of petitioner/plaintiff namely, 'ALBAIK' or 'KSA ALBAIK INTERNATIONAL' or any other name or mark similar or deceptively similar of 'ALBAIK' and passing off their goods / services by adopting a trade name which is identical or deceptively similar to petitioner / plaintiff's registered trademark 'ALBAIK' with any prefix or suffix and passing off their goods/services by marketing, advertising and offering its goods and services or in any other manner using or allowing 3rd parties to use petitioner/plaintiff's trademark 'ALBAIK' as a part or whole or its website/domain name https://bandraalbaikinternational.com, email if any and other social media accounts of the defendants denoting petitioner/plaintiff's trademark 'ALBAIK' either as trademark or part of trademark, trade name, corporate name, domain name, email address or any other manner until further orders.
- 3. Comply clause (a) and (b) proviso to Order 39, Rule 3 of the Code of Civil Procedure. Issue emergent notice to respondent. For return of notice: 23.5.2022.
